

The Islamic Association of Arabi began as a small masjid (Masjid Yaseen) and within five years, the first boarding Islamic institute in the United States was established. Between 1990 to 2005, sixty-five American born Muslim children completed memorization of the Holy Quran and another twenty-one went on to become Scholars in Islam. Today, Alhamdulillah, it is a sense of great pride that these products of The Islamic Association of Arabi are serving various masjids and communities all over our nation.

HURRICANE KATRINA

Through the wisdom of Allah, the Masjid and Islamic Institute were destroyed due to Hurricane Katrina. Consequently, Muslims of that community dispersed throughout the country, and the decision to re-establish Masjid Yaseen and the Islamic institute in the Dallas Metropolitan area was made. By the grace of Allah, at the present, The Islamic Association of Arabi has five masjids and two Madrasas under its umbrella: the first Masjid Yaseen in Arabi Louisiana, the second Masjid Yaseen in Shreveport Louisiana, the third Masjid Yaseen in Garland TX, a fourth Musallah in Greenville TX, and a fifth Musallah in Plano TX. Two sister entity Musallahs also operate in Rockwall and Rowlett, TX.



ZONING VERIFICATION LETTER

RE: Zoning Verification – 1100 Executive Drive (Corporate Square, 1st Installment – Lot 1A, Block 2), Richardson, Texas

The above-referenced property is zoned PD Planned Development District (PD) under Ordinance Number 4322 (a.k.a. Collins/Arapaho TOD & Innovation District Form Based Code). Ordinance Number 4322 rezoned the area and established the Collins/Arapaho Planned Development District in December of 2019.

Attached is Ordinance Number 4322 which includes permitted uses, building and area regulations, parking requirements and regulations related to nonconforming properties. The subject property is located in the Employment Sub-district. The use of the property as a "Church" is allowed by right in this sub-district. The definition of a church means "any facility used principally for regular assembly for religious worship and those accessory uses or activities which are customarily associated therewith." Accessory uses such as a childcare center and religious-based classes or trainings are allowed if they are affiliated, operated, and managed by the "church".

The City Building Inspection Department issues all Certificates of Occupancy. At the time the Certificate of Occupancy was issued, the site was required to be in compliance with zoning regulations, the approved site plan and building codes. 




